THIS DEED Made the first day of April in the year nineteen
hundred and twenty seven. BETWEEN David Rohrer and Barbara L.
Rohrer his wife of the Township of Upper Leacock, County of
Lancaster and State of Pennsylvania parties of the first part
hereinafter called the grantors, and Freeland H. Puckwalter Jr. of the same place party of
the second part hereinafter called the grantees. WITNESSETH That in consideration of twelve
thousand (\$12000.00) Dollars in hand paid the receipt whereof is hereby acknowledged the said
grantors do hereby grant and convey to the said grantees his heirs and assigns forever.

ALL THAT CERTAIN acreage herein and tract of land situate in the Township of
Upper Leacock County of Lancaster and State of Pennsylvania bounded and described as follows
to wit: Beginning at a stone in line of land of Levi Stoltzfus thence by the same north trea-
ny and three fourths (20 $\frac{1}{4}$) degrees west sixty three and three tenths (63.3) perches to a
stone; thence by land of Adam Bitzer and Ezra Cook North forty eight and three fourths (48 $\frac{3}{4}$)
degrees east seventy six and four tenths (76.4) perches to an Elm tree; thence by land of
Penjamin Rupp south thirty seven degrees (37) east one hundred thirty three and three tenths
(133.3) perches to a Hickory stump; thence by lands of Abram Leaman, Jacob Kochel and Stephen
Stoltzfus south eighty four and one fourth (84 $\frac{1}{4}$) degrees west one hundred ten perches (110)
to the place of beginning. Containing fifty acres (50) and fifty three (53) perches neat
measure.

BETWEEN the same premises which Isaac Rohrer widower by his deed dated March 28, 1878
and Recorded in the Recorder's Office in and for Lancaster County in Deed Book S. Vol. 21,
Page 311, granted and conveyed unto David Rohrer his heirs and assigns forever. And the said
grantors do hereby warrant specially the property hereby conveyed. In witness whereof said
